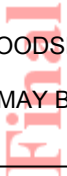

DOC – T038 “BREAD” CONTRACT (Statewide)

Purpose:

Establish a contract from the item listed for all state agencies. Contract prices are available to all local governmental agencies and schools. See attachment to the RFB for a list of correctional locations, as the Department of Corrections will be the main user of this contract. Vendors may submit a list of “sub-vendors” with the RFB response.

Award:

The award shall be made to the lowest responsible bidder meeting all specifications

Unit of Measure:

The unit of measure indicated “XLF OR LOAF” is to be bid, or it could result in rejection of the bid response.

Quantity:

The exact quantity of this item is unknown. The Division of Purchasing does not guarantee the State will buy any amount. Orders will be placed by agencies as needed and give complete shipping instructions.

Payment:

Invoices will not be paid until all items have been delivered to the destination in satisfactory condition, 30 days in arrears.

Freight:

Bid is F.O.B. destination. Any freight charges must be included in the bid prices.

Deliveries:

No deliveries are accepted on weekends or legal holidays. Delivery times are 7:00 am until 2:00 pm.

**** Please contact the; KITCHEN AT THE PRISON AND/OR THE BUSINESS MANAGER AT EACH LOCATION FOR DELIVERY INSTRUCTIONS.**

All packing slips must contain purchase order numbers or be rejected. Items **where applicable** must be palletized on standard 4-way pallets, 40" x 48" normally 48 cases to pallet and shrink wrapped.

Default:

When a vendor defaults on a contract/purchase order, the State can procure the goods or services from other sources and hold the vendor responsible for any excess in price/handling. The vendor may be barred from bidding for an indeterminate period.

Additional information:

Additional information may be requested for evaluation and must be furnished without charge to the State within 5 (five) days of request.

Contract period:

Establish a 12 month contract with an option to extend for a second, third, fourth, and fifth 12 month period with the same pricing, terms and conditions. The second, third, fourth, or fifth 12 month period, if agreed by both parties, would begin the day after the first, second, third, or fourth 12 month period expires. Any successive extension must have written approval of both the state and vendor no later than 30 days prior to expiration of the previous 12 month period.
